Despite the inherent and known risks I hereby expressly waive and release any and all claims, now known or hereafter known, against the Releasees on account of personal or psychological injury, illness, pain, suffering, temporary or permanent disability, death, property damage, or financial loss arising out of or attributable to being on the Premises or participating in the Activities, whether arising out of the negligence of the Releasees or otherwise. The Merchant covenants not to make or bring any such claim against the any of the Releasees, and forever releases and discharges the Releasees from liability under such claims. The Merchant expressly waives and releases all claims on behalf of themselves, their spouses, parents, children, guardians, heirs, assigns, personal representatives and estate as well as any other person who or entity that could represent the Merchant or act on the Merchant's behalf.

The Merchant agrees to hold harmless and indemnify and defend the City and its elected officers, managers, employees, agents, and volunteers, from all liability claims, demands, causes of action, suits or judgements for death or injury to persons or property, including attorneys' fees and costs, arising out of or in connection with Merchant's use of the premises or the intended use thereof or related to the Activities from all liability claims arising out of:

- the actions of the Merchant, the Merchant's employees, agents, helpers or any other persons using the assigned Merchant space at the Merchant's invitation and on the Merchant's behalf;
- 2) items brought to the premises (including vehicles, booth materials, umbrellas);
- 3) items sold at the Farmers/Winter Market; and
- 4) other liability except those actions or inactions arising out of the City's willful or wanton conduct.
- II. Jury Waiver.

The Merchant knowingly, voluntarily and unconditionally agree to give up my right to a trial by jury in any legal action against the City or the Releasees.

The Merchant affirms that they have received and read this Agreement and the rules set forth above and agree to abide by them while participating in the Activities. Failure to abide by the rules may lead to the Merchant becoming ineligible to vend in the City of Robins.

I authorize the City of Robins to (i) conduct criminal background checks as necessary and (ii) receive information from any law enforcement agency, including police departments and sheriff's departments, of this state or any other state or federal government, to the extent permitted by state and federal law, pertaining to any convictions I may have had for violations of state or federal criminal laws. I understand I will have the opportunity to explain any convictions and that the City will analyze any convictions on a case by case analysis using the following factors: the nature and gravity of the offense; the amount of time passed since the conviction; the relationship between the conviction and the nature of the volunteer activity; and other mitigating factors.

BY SIGNING, I ACKNOWLEDGE THAT I HAD SUFFICIENT TIME TO REVIEW AND CONSIDER THIS AGREEMENT, THAT I HAVE READ AND UNDERSTOOD ALL OF THE TERMS OF THIS AGREEMENT AND THAT I AM VOLUNTARILY AND UNCONDITIONALLY GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE CITY OR ANY RELEASEES AND THE RIGHT TO A TRIAL BY JURY.
