

Roll call was taken with Dennis Trachta, Todd Roberts, Jay Goodin, AJ Hester and CJ McDonald attending along with Planning and Zoning Administrator Vance McKinnon, City Engineer Kelli Scott and City Clerk Lisa Goodin. Commission members Tim O'Hara and Matt Mitzel were absent.

Absent Chairperson and Zoning Administrator reports, Roberts moved to approve the agenda, Hester seconded and all votes were aye. Goodin moved to approve the minutes of the May 14th, 2025 meeting, Roberts seconded and all votes were aye.

All those present conducted a work session to investigate and discuss several matters. First, Future Land Use Map which is being considered for update. Second, the re-zoning of commercial properties within the City of Robins to better align with adopted zoning districts. Third, Robins Zoning Map, to which an update is being considered.
